



## 1. About Edith Cowan College

Edith Cowan College (ECC) is a joint venture operation between Edith Cowan University (ECU) and Navitas Limited. ECC (formerly PIBT) is the founding college of Navitas Limited, with over 20 years' involvement as ECU's on-campus pathway provider, delivering high quality courses in an environment which encourages students to achieve excellence in their studies.

ECC is located on both the Joondalup and Mount Lawley campuses of ECU in Perth, Western Australia. ECC offers diploma programs on the ECU Joondalup campus in:

- Commerce
- Hotel Management
- Communications and Creative Industries
- Science (Computing/IT)
- Science (Engineering Studies)
- Science (Health Studies) including Nursing.

Following successful completion of the Diploma (Year 2) program students are eligible for entry into the second year<sup>1</sup> of the respective bachelor degree at ECU.

A trimester system offered in February, June and October each year allows students to fast-track their studies and complete most diplomas in eight months. ECC's supportive learning environment ensures students are well prepared to enter university with confidence.

ECC also offers the Post-Graduate Qualifying Program (PQP) to international students only. This non-Award program on the ECU Joondalup campus is designed to lead students into ECU's master's degrees in the School of Business and Law with one unit of advanced standing. The

program is designed for students who already have tertiary qualifications but have not qualified for direct entry into the university masters degrees.

ECC English language programs offered on the ECU Mount Lawley campus are also available for people from non-English speaking backgrounds and as a direct entry pathway for international students wishing to undertake university study at ECU.

## 2. Admission Criteria

### A. Applicants with Higher Education Study

Applicants with Higher Education Study are those whose highest level of study since leaving secondary education is a higher education course, such as a university degree or university-level Diploma. This includes applicants who have completed a higher education course, those who are currently studying a higher education course at another education provider and want to transfer to ECC, or those who are currently studying a higher education course at ECC but wish to change course.

Completion in part (minimum 4 units) or whole, of a higher education course will satisfy the broad academic requirements for entry into an ECC Diploma; but separate evidence of English proficiency, and/or evidence of course-specific pre-requisites might also be required.

ECC may recognise partial completion of a qualification under the principles of Recognition of Prior Learning (RPL). Originals or certified copies of academic transcripts, unit outlines and supporting documentation are required prior to processing.

ECC delivers two bridging/enabling programs in its ELICOS and Post-graduate Qualifying Program (PQP). ELICOS is designed to satisfy ECC's English proficiency requirements; whilst PQP can be used to satisfy the academic and English proficiency requirements for entry into a number of ECU Masters programs.

### B. Applicants with Vocational Education and Training (VET) Study

Applicants with vocational education and training (VET) study are those whose highest level of study since leaving secondary education is a VET course. This includes study at a public TAFE or other VET provider, whether a qualification was completed or not. Applicants with VET study may have other qualifications such as a Year 10, 11 or 12 secondary school certificate.

Graduating from TAFE or another Australian Qualification Framework (AQF) provider can qualify you for entry to ECC.

Entry into an ECC Diploma (Year 1) requires a minimum completion of a Certificate III (or comparable) level course. Entry into an ECC Diploma (Year 2) requires completion of a minimum Certificate IV (or comparable) level course. Separate evidence of English proficiency, and/or evidence of course-specific pre-requisites might also be required.

### C. Applicants with Work and Life Experience

#### **Finished Secondary School More Than Two Years Ago**

Mature-aged applicants (20 years of age and over) may be admitted to the diploma courses without meeting the formal academic qualifications if they have relevant work experience and/or other acceptable qualifications.

Advanced Standing may be granted towards an ECC Course for assessable learning outcomes achieved through formal learning and/or informal learning, work related experience and/or life experience, to an extent that is consistent with maximising student progression while maintaining established academic standards.

### **Bridging and Enabling Course Entry**

Admission to any ECC course can also be offered to applicants who may not meet the entry criteria but, because of their age and/or prior experience, can demonstrate a high probability of success in the chosen course. This decision is made by the Academic Director in consultation with the Director of Marketing and Admissions.

ECC may recognise alternative forms of entry qualifications which are targeted at improving access for ATSI students or others who may be experiencing disadvantage in accessing and participating in education. To that end, a *Portfolio Entry* process may be applied. Portfolio Entry requires the applicant to submit documents as evidence of informal learning together with details of their abilities through work experience, training documents, resume, and a personal statement relating to skills/abilities. The application will be assessed by the Academic Director (or nominee) on a case-by-case basis.

Applicants with disabilities must indicate on their application their disability status. Such students will be asked to provide further details of their disability in order for ECC to assess their specific study requirements. No policy or practice of ECC shall discriminate against persons with disabilities except where, in the opinion of the College Director/Principal, the provision of additional goods, services or facilities would go beyond “reasonable adjustment” and impose an unjustifiable hardship on the College.

### **D. Applicants with Recent Secondary Education (within past two years)**

#### **Australian Year 12 Students**

Applicants with recent secondary education are those whose admission is primarily based on completing Year 12, but also includes those who may have completed their senior secondary studies with a TAFE or other VET provider frame. This can include applicants whose secondary education was undertaken interstate or overseas.

Entry into ECC Diplomas (Year 2) requires a minimum ATAR of 50, or a minimum 50% in four Year 12 WACE subjects (General or ATAR); plus a pass (i.e. 50%/C-grade) in English, or separate evidence of English proficiency.

Students who undertake the International Baccalaureate in Western Australia will have their IB score converted to an equivalent Australian Tertiary Admission Rank (ATAR) by TISC.

### **Selection Rank Adjustments**

ECC makes no adjustments, nor applies any bonus points to ATARs.

### **Criteria that may Apply In Addition To ATAR**

Admission to any ECC course can also be offered to applicants who may not meet the entry criteria but, because of their age and/or prior experience, can demonstrate a high probability of success in the chosen course. This decision is made by the Academic Director in consultation with the Director of Marketing and Admissions.

ECC may recognise alternative forms of entry qualifications which are targeted at improving access for ATSI students or others who may be experiencing disadvantage in accessing and participating in education. To that end, a *Portfolio Entry* process may be applied. Portfolio Entry requires the applicant to submit documents as evidence of informal learning together with details of their abilities through work experience, training documents, resume, and a personal statement relating to skills/abilities. The application will be assessed by the Academic Director (or nominee) on a case-by-case basis.

### **Interstate Year 12**

ATAR scores are deemed comparable, regardless of the state or territory in which the applicant completed Year 12.

In addition to an Overall Position (OP) eligible applicants from Queensland will be eligible to receive an ATAR calculated by the Queensland Curriculum & Assessment Authority (QCAA).

## **3. Additional Information**

### **A. Aboriginal and Torres Strait Islander People**

To ensure students have the best chance of success, all applicants are required to provide evidence of academic background and English language proficiency, prior to commencing a course. ECC welcomes applicants with both domestic and equivalent international qualifications.

### **Medical, Health and Wellbeing Services**

ECC students can access the ECU on-campus Medical Centre which is staff by qualified General Practitioners offering general consultation, specialist referrals, sports medicine, pre-employment checks, travel/workplace vaccinations, contraception advice, STD screening, pregnancy testing, advice, minor surgical procedures, blood tests, care plans, lifestyle counselling, etc. Medical facilities are available on both the ECU Joondalup and Mount Lawley campuses.

### **Library/Computing Services**

ECC students have near full access to ECU's library services including print collection, e-books, e-journals, videos, most multi-media packages, computer software and numerous online journals. ECC students also have access to major library databases (subject to licencing limitations) to enable them to search journal articles, statistics, case law, conference papers, newspapers, standards, reports, etc. High-demand resources are available from Closed Reserve or E-Reserve

### **Classrooms and Computer Labs**

All classrooms and computer labs are fitted with state-of-the-art audio-visual equipment such as data projectors, DVD, VHS and internet access. ECC classrooms have varied capacity whilst computer labs have capacity for 24 students. Students who study Computer-Aided Design (CAD) use drawing boards during the first half of trimester and computer labs in the second half.



### Science Labs

ECC students have access to specialised laboratory facilities for biology, chemistry, physics and electrical engineering workshops. Access to these facilities not only enhances the learning experience, but also introduces students to lab protocols and safety procedures.

### E-Lab and Wi-Fi

Students can freely access the internet via the wireless network on campus. The ECU E-Lab is open during normal office hours and (for a refundable \$25) students can access it 24/7 with an after-hours access card. The ECU E-Lab offers both PC and MACs uploaded with current software and specialist software for study purposes. Students can also use printers, scanners and MMR equipment to create multi-media presentations.

### Learning Assistance

From their initial contact, students are assessed against established standards for English language and academic background. Applicants who meet the academic entry but lack sufficient English language competency are offered the Academic English Program (AEP) within the ECC ELICOS division.

On arrival, all new students undergo a two-day orientation program focussing on *Getting Connected*, enrolment advice and *Steps-to-Success* workshops. See:

ECC has its own LMS (Moodle) which offers an enhanced platform to facilitate student learning online. Moodle contains a wealth of information such as unit outlines, assessments, lecture notes, online quizzes, forums, wikis, links to websites, multi-media links, etc. The Student E-Café section includes generic resources relating to academic learning support, referencing, academic misconduct, language support, exams, student wellbeing, etc.

Academic/Program Coordinators allocate time each week so students can seek course-specific assistance. These free sessions reinforce fundamental concepts and offer guidance with respect to interpreting assessment requirements.

### Personal Safety and Security on Campus

As ECC is located on the Edith Cowan University Campus West, ECC staff and students have access to ECU Security Services who offer professional and highly trained security officers 24 hours a day, seven days a week. Anyone who is concerned about their safety or would like to be accompanied to their car after hours, can contact security.

- **Report**—allows anyone to lodge an incident via text and/or photos (eg. Report suspicious activity, request front gate to be locked/unlocked, staff working after-hours, etc.)
- **Message**—allows students/staff to receive SMS messages (eg. In case of fire, evacuation).
